Deed of Change of Name (Deed Poll) for a Minor

- AT ALL times our daughter shall hereafter in all records, deeds, documents and other writings and in all actions and proceedings, as well as in all dealings and transactions and on all occasions whatsoever use and subscribe the said name of Rowdha ABDUL-AHAD ALI as her name in substitution for her former name of Rowdha ABDULAHAD so relinquished as aforesaid to the intent that she may hereafter be called, known or distinguished by the name of Rowdha ABDUL-AHAD ALI only and not by her former name of Rowdha ABDULAHAD
- WE AUTHORISE and require all persons at all times hereafter to designate, describe and address our daughter by her forename of Rowdha and her adopted and substituted surname of ABDUL-AHAD ALI




